## Highlights of the July 26th CCL Hawaii meeting

The July 26th CCL Hawaii meeting featured Hawaii County Council Chairwoman Heather Kimball. (Please NOTE: Heather's presentation was around 2 weeks prior to the Maui/Hawaii fires)

Before entering office, Heather worked as a climate scientist and owner of a consulting firm that assists in carbon mitigation and climate change adaptation policy. Heather talked about her legislation that establishes the newly created Hawaii County Office of Sustainability, Climate, Equity and Resilience (OSCER)

<u>Urge Congress to cosponsor the Increased TSP Access Act</u> - TSPs can help protect over HALF of America's forests.

The <u>Technical Service Providers Act</u> helps farmers, ranchers, and forest owners access critical conservation programs and empowers these producers to implement climate-smart programs.

Notably, the TSP Access Act already has Republican and Democratic support in Congress!
